The committee is made up of two current researchers or teacher-researchers not involved in the thesis work and from outside the research team, one of whom is from outside the laboratory hosting the doctoral student and from outside the ComUE. The aim is to monitor the progress of the thesis, correct any problems and advise the PhD student.

One of the members must be close to the PhD student, so that the latter can meet with him or her easily if necessary, but outside the scientific environment, research team or immediate staff of the supervisor, in order to guarantee his or her independence. The other member must be from outside the ComUE (Caen, Le Havre, Rouen) and fairly close to the scientific field of the thesis. At least one of the members must be an academic (researcher or teacher-researcher) with an HDR. The members of the monitoring committee may sit on the jury for the thesis defence, but may not act as rapporteurs for the thesis.

It is important that the PhD student feels comfortable with the members of the committee, so it is the PhD student's opinion that takes precedence in the event of disagreement with the supervisor. The PhD student may ask for advice from the PhD students elected to the ED council.
